 Principal by any customer, this obligation will become void. If this obligation is not void, it remains in full force and effect,
 subject to the following conditions:

1. As of the 31st day of March, 2015, this bond will be in full force and effect indefinitely.
 Continuation or renewal certificates are unnecessary.
2. The surety may, at any time, terminate this bond by submitting written notice to the Texas Department of
 Insurance thirty (30) days prior to the termination date. The surety, however, remains liable for any defaults under
 this bond committed prior to the termination date.
3. In no event will the aggregate liability of the Surety under this bond, for any or all damages to one or more
 claimants, exceed the penal sum of this bond.
